ALL that certain piece, parcel or lot of land with all improvements thereon situate, on the northwest corner of Pendleton Street and Memminger Street in the Fifth Ward of the City of Greenville, County of Greenville, State of South Carolina, as shown on the City Block Book at 80-2-11, and being more particularly described as follows:

BEGINNING at a stake on the northwest corner of said streets and running thence with Memminger Street in a northerly direction 220 feet; thence in a line parallel with Pendleton Street in a westerly direction 70 feet; thence in a line parallel with Memminger Street in a southerly direction 220 feet to Pendleton Street; thence with Pendleton Street in an easterly direction to the beginning corner, approximately 70 feet.

Being the same lot of land conveyed to Edna L. Pack by Mary L. Pack in Volume 73, page 79, RMC Office for Greenville County on July 18, 1921. Thereafter Edna L. Pack died testate leaving the residue of her property to Annette M. Henry, Louise Bentz Tourtellot and William S. McCollum as shown in Paragraph VI of the Last Will and Testament of Edna L. Pack as shown in the Probate Judge's office for Greenville County in Apartment 1335, File 24.

This conveyance is made subject to any and all existing and recorded easements, rights of way and restrictions affecting said property.
