of South Carolina, described below:

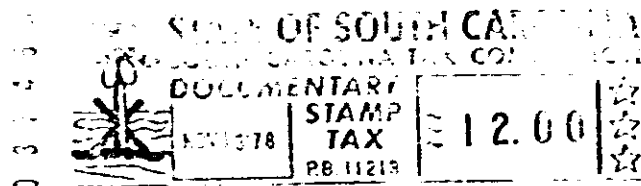
