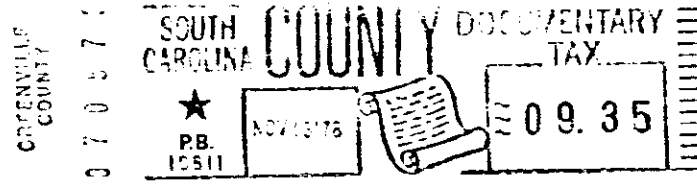
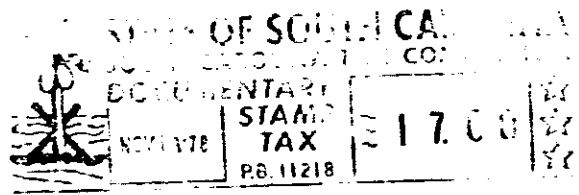

ALL those lots of land in the State of South Carolina, County of Greenville being known and designated as lots nos. 112 and 113 on a plat of Hunters Acres dated May, 1962 and recorded in Plat Book BB at page 51 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southerly edge of Hill Street at the joint corner of lots nos. 113 and 132 and running thence along the southerly edge of Hill Street, S. 88-46 E. 202.3 feet to an iron pin at the intersection of Hill Street and Boyd Avenue; thence along the westerly edge of Boyd Avenue, S. 10 W. 195.9 feet to an iron pin at the joint front corner of lots nos. 111 and 112; thence N. 80 W. 200 feet to an iron pin; thence N. 10 E. 165.4 feet to the point of beginning. This is one of the lots conveyed to the late J. M. Griffin by deed recorded in Deed Book 458 at page 289 and is subject to restrictive covenants contained in said deed.
