ALL that piece, parcel or lot of land with all buildings and improvements thereon, situate, lying and being on the northwestern side of Yorkshire Drive (formerly known as Mable Avenue), in Greenville County, South Carolina, being shown and designated as Lot No. 62 on a plat of Property of James M.
