LUCILLE F. LEWIS, her heirs and assigns;

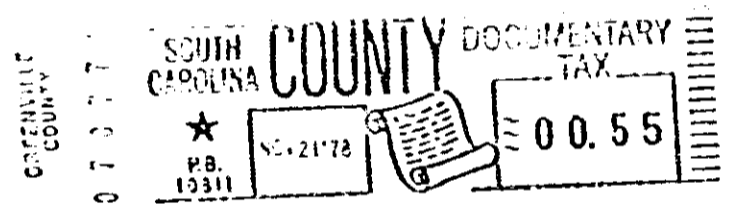
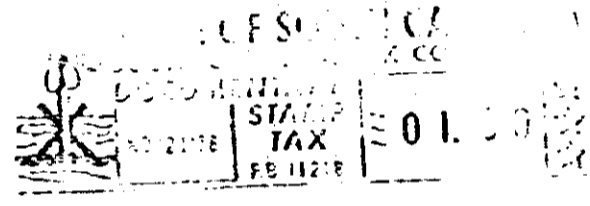
