County of Greenville, State of South Carolina, described below:

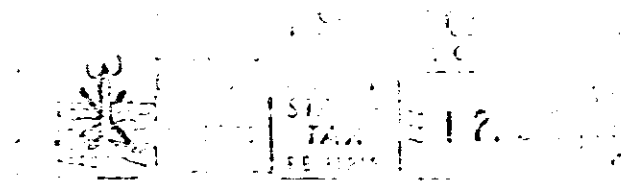
All that certain piece, parcel or lot of land located in the
