ALL that certain piece, parcel or lot of land, together with the improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, near Monaghan Mills, and being known and designated as Lot 131 according to a plat of a Subdivision known as City View which plat is recorded in the Greenville County R.M.C. Office in Plat Book A at Page 461, and having, according to said plat, the following metes and bounds, to wit:
