in consideration of Thirty-Seven Thousand Nine Hundred (\$37,900.00) ----- Dollars,

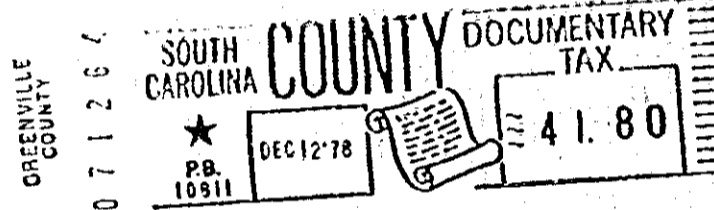
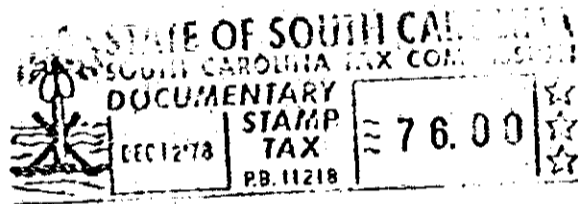
