ALL that certain piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina within the corporate limites of the City of Greenville, being described on a survey made by Dalton & Neves in February, 1927, and having the following metes and bounds, to-wit:

BEGINNING at a point on the southern side of West Earle Street at the joint front corner of this lot and lot owned by E. E.
