ALL MY RIGHT, TITLE AND INTEREST, THE SAME BEING AN UNDIVIDED FIFTY-ONE PER CENT (51%) INTEREST, IN AND TO THE FOLLOWING DESCRIBED PROPERTY:

ALL that certain piece, parcel or lot of land in the County of Greenville, State of South Carolina, and on the Northerly side of Woods Lake Road, and being shown and designated as Lot No. 7 on plat of property of C. F. Putman prepared by C. O. Riddle, R.L.S., May, 1955, and having, according to said plat the following metes and bounds:
