an undivided 2/16ths interest in and to the following described property:
ALL That parcel or tract of land situate and being in the dismal area between Caesar's Head and Table Rock west of the Geer Highway in Cleveland Township, Greenville County, South Carolina, being shown on plat recorded in Plat Book Y, at pages 114-118 as a portion of the 737 acres No. A-III Thomas Wilson (Guignard) and containing 350 acres and being described as follows:

BEGINNING at a point in Matthews Creek and running thence N. 67-39 E. ^{2530.44} 38.34 chains to an iron pin; thence N. 19-42 W. 34.18 chains to an iron pin; thence N. 21-27 W. 40.17 chains to an iron pin; thence ^{2235.88} continuing N. 21-27 W. 22.1452 chains to an iron pin; thence ^{2651.22} S. 67-52 W. 28.38 chains to an iron pin; thence S. 19-51 E. 25.11 chains to an iron pin; thence ^{1873.08} S. 70-10 W. 18.49 chains to a point in Matthews Creek; thence down Matthews Creek following the meanders thereof approximately 75 chains to the beginning corner. ^{1220.34}
