and release unto C. C. Hice and Linda B. Hice, their heirs and assigns forever:

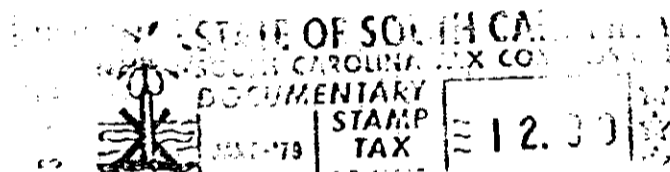
Our remaining one-half (1/2) interest in and to the following described property:
