release unto Virginia C. Summey, her heirs and assigns, forever:

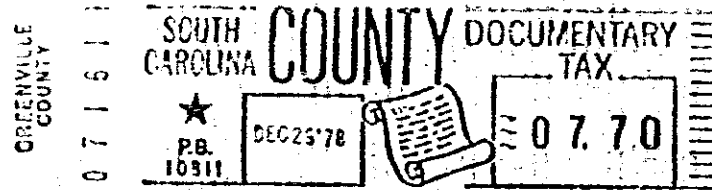
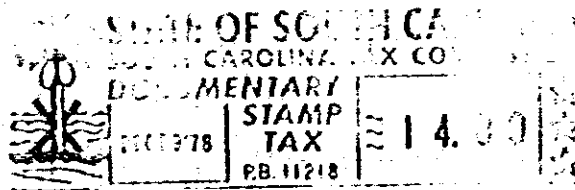
All that piece, parcel or lot of land, situate, lying and being in Greenville
