THIS CONTRACT made and entered into this 5th day of January 1979, by and between Leila H. Crocker, hereinafter referred to as the Seller and J. Fred Crocker and Nancy H. Crocker, hereinafter referred to as the Purchasers,

WITNESSETH

For and in consideration of the mutual covenants herein expressed and the further consideration of One Dollar (\$1.00) by the Purchasers to the Seller, paid receipt of which is hereby acknowledged, the Seller agrees to sell and the Purchasers agree to purchase all that certain land described as follows:

> All that certain piece, parcel or lot of land, lying and being situate in the State of South Carolina, County of Greenville, O'Neal Township, about one mile northwest of the City of Greer, and bounded on the South by land of E. G. Ballenger's line; thence with his line S. 60-20 E. 530.5 feet to the beginning corner.

In consideration of the said premises, the Purchasers agree to pay to the Seller the sum of Twenty-two Thousand and No/100 (\$22,000.00) Dollars which shall be paid as follows:

> The sum of One Thousand Five Hundred and No/100 (\$1,500.00) Dollars has already been paid, receipt of which is hereby acknowledged. The balance of Twenty Thousand Five Hundred and No/100 (\$20,500.00) Dollars shall be paid in monthly installments of Two Hundred and 30/100 (\$200.30) Dollars for one hundred and eighty (180) consecutive months, commencing on January 10, 1979, and being due on the tenth (10th) day of each month thereafter.
