in consideration of Four Thousand (\$4,000.00) ----- Dollars,

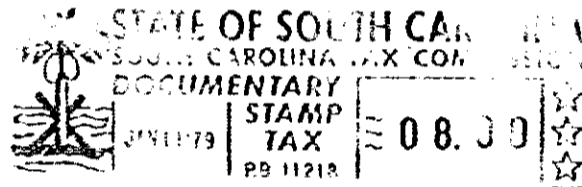
