Carolina 29606, his heirs, successors and assigns forever:

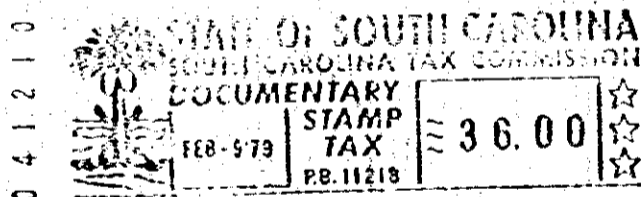
All those certain pieces, parcels or lots of land located in the
