In consideration of Twelve thousand and No/100ths(\$12,000.00)----- Dollars,
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and
release unto SARA F. TRAYNHAM, her heirs and assigns forever:

ALL that piece, parcel or lot of land, lying being and situate on the northern
side of Southern Road, County and State aforesaid, containing 15.0 acres more
or less and being more particularly shown on Plat entitled "Survey for
Florine Traynham", dated February 1979, prepared by James L. Strickland, RLS,
said Plat being recorded in the RMC Office for Greenville County in Plat Book
7A at Page 4, and having according to said Plat the following metes
and bounds, to-wit:

BEGINNING at a nail and cap in the center of Southern Road at the joint front
corner of property now or formerly owned by Grantors and running thence N. 02-
