WILLIAM E. HASELDEN, his heirs and assigns forever,

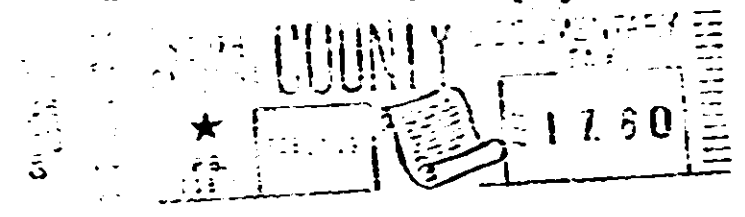
