All that parcel or tract of land in Greenville County, State of South Carolina, located about 1 1/2 miles South of The Town of Pelham, in Butler Township, Being Tract No. 5 as shown upon plat "Subdivision of David Wood Property" prepared by Wolfe & Huskey, Inc., Engineering and Surveying, Lyman, S. C. dated March 25, 1975 and being more particularly described as follows:

Beginning at an iron pin joint corner of tracts 4, 3, 6 and 5 and running thence with the common line of tract No. 6, S 37 04 W, 239.2 feet to an iron pin; thence, N 51 09 W, 42 feet to an iron pin corner of tract No. 7, thence continuing for a total distance of 404 feet to the center of a small creek; thence with the creek as the line, the tie line is N 44 14 E, 240.8 feet to a point; thence leaving the creek and running with the common line of tract No. 4, S 51 09 E, 374 feet to the point of beginning, containing 2.06 acres more or less.
