and release unto ONEAL M. OWEN AND ATHILEE M. OWEN, THEIR HEIRS AND ASSIGNS FOREVER:

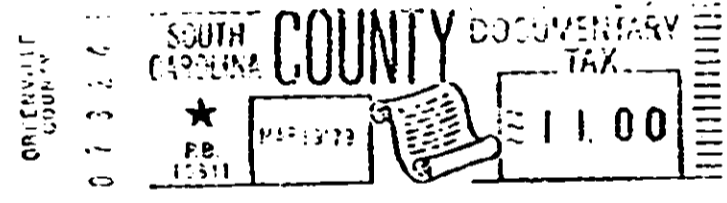
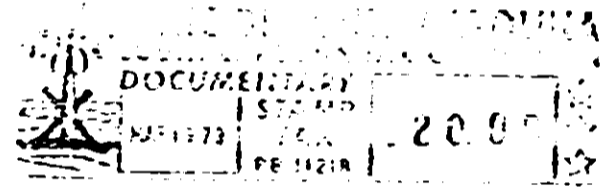
