ALL that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina and known and designated as Lot 422, Section No. 2 as shown on a plat entitled "Subdivision for Abney Mills, Brandon Plant, Greenville, S. C." made by Dalton & Neves, February, 1959 and recorded in the R.M.C. Office for Greenville County in Plat Book QQ at Pages 56-59 inclusive and having according to said plat the following metes and bounds:
