release unto Inez C. Lytle, her heirs and assigns forever:

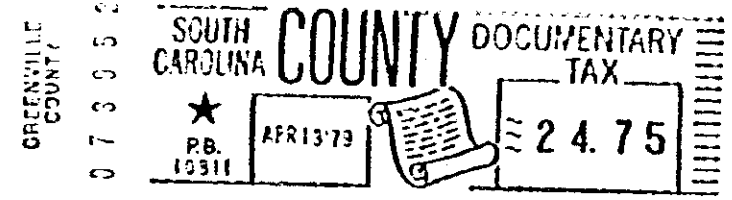
