

BEGINNING at an iron pin on Cox Street at corner of property now or formerly owned by H. J. Forrester and running thence with Cox Street, N. 41-30 W. 65 feet to an iron pin; thence N. 48-30 E. 183 feet more or less to an iron pin on a 14 foot alley; thence along said 14 foot alley, S. 41-30 E. 65 feet to an iron pin at corner of property now or formerly of Forrester, S. 48-30 W. 183 feet more or less to the beginning corner.
