All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina at the northwest corner of Tindal Alley and a twelve foot alley near Rutherford Street, in Ward One of the City of Greenville, as shown by plat recorded in Plat Book F, page 177, and more particularly described as follows:

BEGINNING at a point on said Tindal Alley, which point is 258.8 feet east of and from Rutherford St., at the corner of Lot now or formerly owned by George Norwood and running thence with said Alley N. 86-26 E. 48 feet to a twelve foot alley; thence with said twelve foot alley in a northerly direction approximately 112 feet to line of property now or formerly owned by Etta W. BEGINNING at an iron pin on south side of Washington St., northwest corner of Lot No. 4 and 50 feet from the corner of the lot owned by Meredith, formerly owned by Mary E.
