Thomas C. Oliver and Sandra M. Oliver, their heirs and assigns, forever:

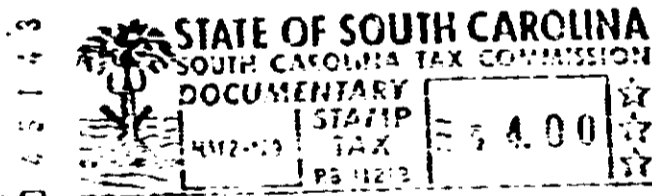
