ALL that piece, parcel or lot of land, being in Bates Township, County & State aforesaid, containing 1.0 Ac., more or less, and according to Plat of Survey prepared by Terry T. Dill, Reg. CE&LS No. 104, Route 2, Taylors, S. C., Dated 7/3/75, having the following metes & bounds, to-wit:

BEGINNING at a point shown on said plat as being approximately 541' from center line of Mill Road, and running N 03-15 W 461' to a corner point; thence S 85-02 E 90' to a corner point; thence S 04-30 E 457' to point on 30' R/W; thence along line of said 30' R/W S 82-50 W 50'; thence still a long line of said right-of-way N 80-05 W 50' to point of beginning.
