and release unto ROY G. COKER, JR., his heirs and assigns, forever:

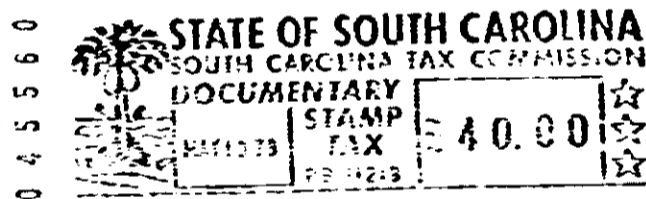
