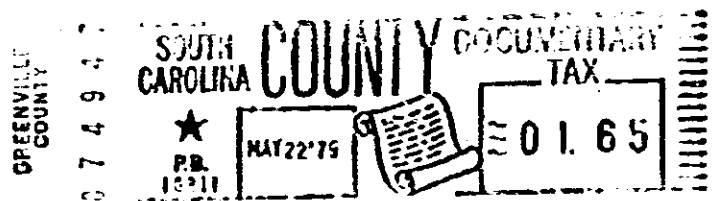
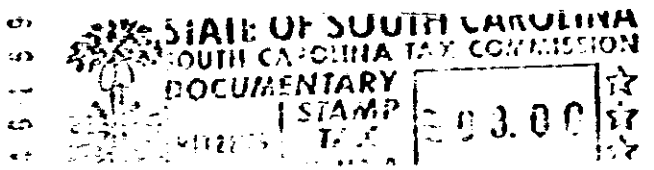
This conveyance is made subject to all easement, restrictions rights of way, both of record and appearing on the ground, and zoning ordinances or regulations of any governmental agency.
