signed in hand paid by the City of Greenville, S. C., the receipt where-
of being hereby acknowledged, (I) (we) hereby grant unto said City of
Greenville, a right-of-way or easement along, over or under (my) (our)
property for the purpose of:

Removing existing concrete sidewalk area and replace-
ment with Portland Cement Concrete to be uniform with
Main Street Improvements.

This property is known and designated as Block Book
Number 1-6-6.

Easement consists of a rectangle area 10 feet by 19 feet-
6 inches on the property described below.

Together with the right of ingress and egress for the purpose of inspect-
ing and maintaining the same.

Said property is described as follows:

Beginning at an iron pin at the northeast corner of Main and
Coffee Streets and running thence with the eastern line of
Main Street N. 20-27 E. 98.5 feet to the outer or northern
edge of the brick wall of the building now or formerly known
as the Vickers-Cauble Building; thence with the outer or
northern edge of said brick wall and with the projection of
the same S. 70-37 E. 129.5 feet to an iron pipe on the eastern
side of an alley; thence with eastern side of said alley S.
20-18 W. 98.9 feet to a point on Coffee Street; thence with
said Coffee Street N. 70-26 W. 129.65 feet to the beginning
corner.
