Continuation of Deed from Bankers Trust of South Carolina as Trustee under the Last Will and Testament of Harriet F. Poole to Harriett E. Poole

BEGINNING at an iron pin at the northeast corner of the intersection of Sutton Drive and Lee Road, and running thence along the east side of Sutton Drive, N. 9-43 W. 192 feet to an iron pin at the corner of Lot 27; thence along the line of that lot, N. 80-17 E. 75 feet, more or less, to the rear corner of the lot heretofore conveyed to Leola Shooks; thence along the line of that lot, S. 9-43 E. 179.3 feet, more or less, to an iron pin at the corner of Lot No. 30 on the north side of Lee Road; thence along the north side of Lee Road, S. 73-08 W. 75.6 feet, more or less, to the beginning corner.
