ALL that lot of land situate on the eastern side of SMYTHE STREET in the County of Greenville, State of South Carolina being shown as Lot No. 119 on a plat of the property of Victor-Monaghan Mills, dated July 1952, revised March 1953, prepared by Pickell & Pickell, Engineers, recorded in Plat Book DD at page 153-B on the R.M.C. Office for Greenville County, and having according to said plat the following metes and bounds, to-wit:
