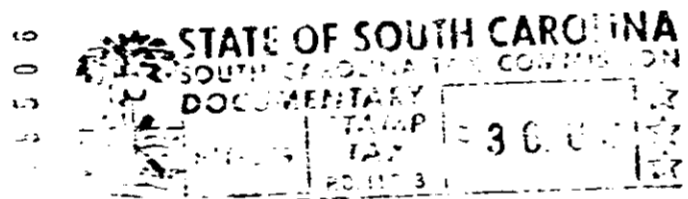

unto **BARRY R. BATSON, his heirs and assigns, forever:**

ALL that piece, parcel or lot of land situate, lying and being on the eastern side of Druid Street, in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lots Nos. 12 and 13 and the southern half of Lot No. 14, Block E., STONE ESTATES, as shown on a plat entitled STONE ESTATES, prepared by C. M. Furman, Jr., dated October, 1931, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book G at page 292 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Druid Street, which pin is 277 feet north of the northeastern corner of the intersection of Druid and Reid streets at the joint front corner of Lots Nos. 11 and 12 and running thence with the line of Lot No. 11, S. 78-38 E., 160 feet to an iron pin in the rear line of Lot No. 36; thence with the rear line of Lots Nos. 36, 37 and 38, N. 11-22 E., 62.5 feet to a stake in the center of the rear line of Lot No. 38; thence a new line through the center of Lot No. 14, N. 78-38 W., 160 feet to a stake on the eastern side of Druid Street, S. 11-22 W., 62.5 feet to the point of beginning.
