ALL that certain piece, parcel or lot of land situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, on the eastern side of Melrose Avenue, and being shown and designated as Lot No. 3 on plat entitled Survey for Greenville County Redevelopment Authority prepared by W. R. Williams, Jr., R.S., dated April 23, 1979, to be recorded in the R.M.C. Office for Greenville County, South Carolina, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Melrose Avenue at the joint front corner of Lots Nos. 3 and 4 and running thence with the line of Lot No. 4 N. 89-37 E. 76.14 feet to an iron pin at the joint rear corner of Lots Nos. 3 and 4; thence with the rear line of Lot No. 3 S. 13-45 E. 47.15 feet to an iron pin at the joint rear corner of Lot Nos. 2 and 3; thence with the line of Lot No. 2 S. 82-13 W. 90.75 feet to an iron pin on the eastern side of Melrose Avenue at the joint front corner of Lots Nos. 2 and 3; thence with the eastern side of Melrose Avenue N. 2-33 E. 57.6 feet to the point of beginning.
