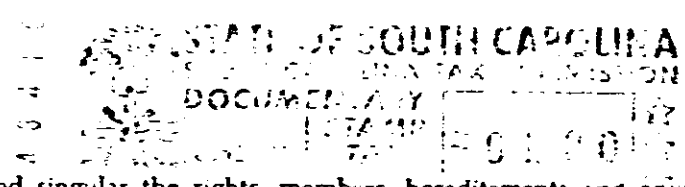
All my right, title and interest, the same being an undivided one-third (1/3) interest, in and to:
