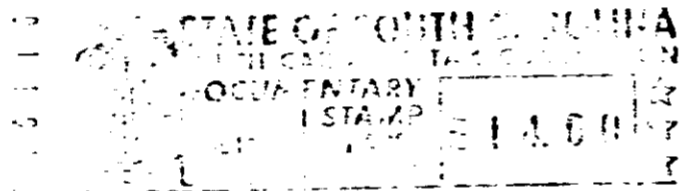
in consideration of Seven Thousand and No/100-----(\$7,000.00)-----Dollars,
