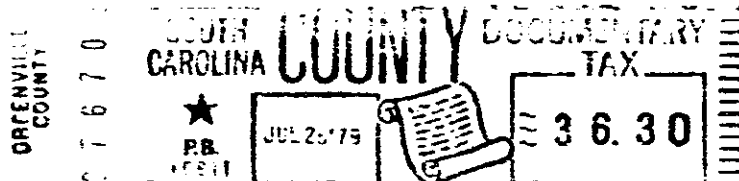
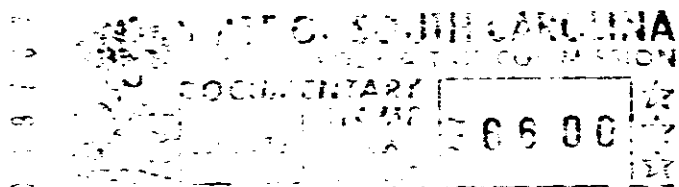
THOMAS GORDON NEWMAN, Jr. and BARBARA GAYLE NEWMAN, their heirs and assigns:
