P. E. Cox, his heirs and assigns forever,

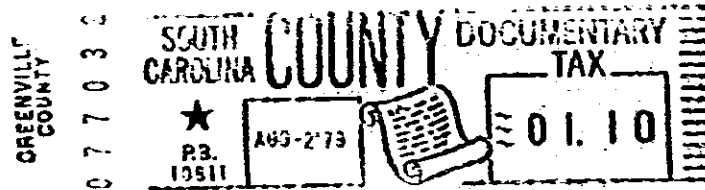
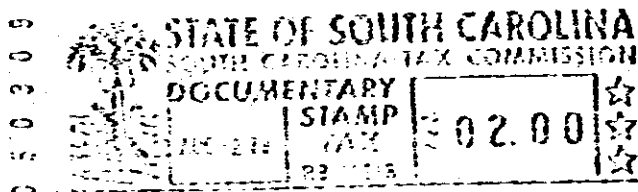
All my right, title and interest, the same being my undivided interest as an heir at law of E. L. Cox and of Sollie H. Cox, in and to the following described land:
