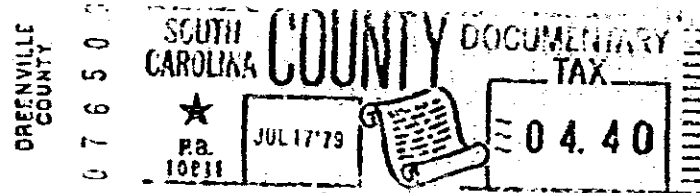
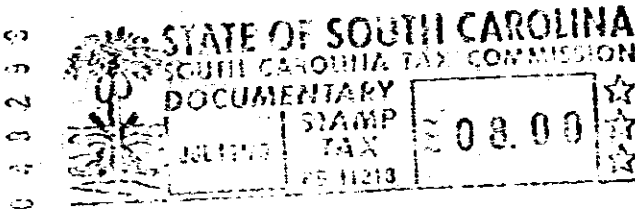

ALL that piece, parcel and lot of land, in the County of Greenville, State of South Carolina, Chicks Springs Township, on the northern side of Longview Terrace, and being portions of Lots Nos. 11, 12 and 14 on plat of Subdivision of Addie W. Long property prepared by Madison E. Woodward, dated 12-18-63, recorded in RMC Office for Greenville County in Plat Book FF at page 25, and having the following courses and distances, to-wit:

BEGINNING at iron pin, southern corner of Lot 13 and Longview Terrace, and runs thence with Longview Terrace, S. 50-30 E. 94 feet to a new point on said Terrace; thence a new line through lots 11, 12 and 14, N. 39-30 W. 273.1 feet to new point on line of Lot No. 14; thence a new line through lot No. 14, N. 48-47 E. 94 feet to iron pin on line of lot previously conveyed to Grantee; thence along line of Grantee's lot, S. 39-30 E. 273.1 feet to iron pin on Longview Terrace, the beginning corner.
