ALL OF MY RIGHT, TITLE AND INTEREST IN AND TO

ALL that certain piece, parcel or lot of land with the buildings and improvements thereon lying and being on the westerly side of Parkwood Drive, in the City of Greenville, S. C., and being designated as Lot Nos. 137 and 138, on plat entitled "North Hills" recorded in the RMC Office for Greenville County, S. C. in Plat Book H, Page 130, and having according to said plat, the following metes and bounds, to-wit:
