**M. William Bashor, Jr., and Anne L. Bashor, their heirs and assigns, forever:**

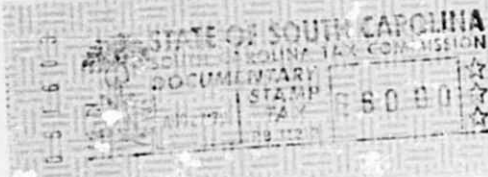
