KNOW ALL MEN BY THESE PRESENTS, that We, RALPH HOWARD, JR. and ANNIE GRACE H. JOHNSON

in consideration of ONE DOLLAR, LOVE AND AFFECTION AND THE PREMISES SET FORTH BELOW

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto HETTIE H. BRIDGEMAN, her heirs and assigns forever:

ALL our right, title and interest, the same being, collectively, an undivided two-thirds (2/3) interest, in and to the following described real estate:

ALL that piece, parcel or lot of land being shown and designated as the southernmost 15.54 acres + tract lying in a northeasterly direction from the center line of Tigerville Road, as shown on a plat entitled, "Survey for Ralph Howard Estate," dated July 17, 1979, by Carolina Surveying Company, said plat being recorded in Greenville County Plat Book 7-L at Page 79, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a nail and cap in the center of Tigerville Road, at the joint front corner with property now or formerly belonging to Olson, and running thence along the center of said Tigerville Road, as follows: N. 34-40 E. 287.4 feet to a nail and cap; thence N. 39-22 E. 147.8 feet to a nail and cap; thence N. 46-21 E. 156 feet to a nail and cap; thence N. 49-25 E. 149.7 feet to a nail and cap; thence along the line of property on this date conveyed by the Grantee and Annie Grace H. Johnson to Ralph Howard, Jr., S. 40-43 E. 1337.2 feet to a point representing the center line of Beaver Dam Creek, the common line of property now or formerly belonging to Walker; thence with the center line of Beaver Dam Creek, the traverse of which is S. 48-45 W. 171 feet, to a point on the line of property now or formerly belonging to Olson; thence continuing with said Olson line along the center of Beaver Dam Creek, N. 71-05 W. 942.5 feet to an old iron pin; thence N. 51-44 W. 427.8 feet to the point of beginning.

This is a portion of that property conveyed to Ralph Howard by deed of Alice Howard, Executrix, dated February 22, 1956, and recorded February 23, 1956, in Greenville County Deed Book 546 at Page 60. Thereafter, said Ralph Howard departed this life testate at Greenville County, South Carolina, on March 20, 1978, leaving as his sole beneficiaries the Grantors and the Grantee herein, they being brothers and sisters of the whole blood, reference being made to Greenville County Probate File designated Apartment 1507, File 26.

The purpose of this conveyance is to partition the total tract conveyed to Ralph Howard by the above referred-to deed.

This conveyance is subject to all restrictions, setback lines, roadways, zoning ordinances, easements and rights-of-way, if any, affecting the above described property.
