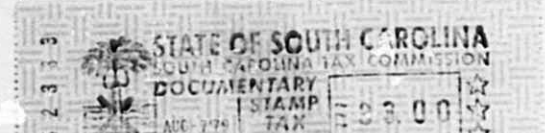
This conveyance is made subject to any zoning ordinances, restrictions, setback lines or easements that may appear of record, on the recorded plat(s) or on the premises.
