WAYNE H. KEENE AND DORIS F. KEENE, their heirs and assigns forever:

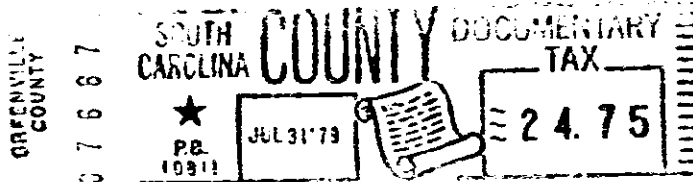
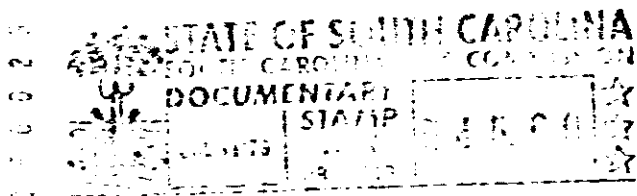
