the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto KENNETH G. SMITH AND KATHRYN L. SMITH, their heirs and assigns forever:

ALL that piece, parcel or lot of land lying and situate in Oneal Township, Greenville County on the northern side of Groce Meadow Road, formerly known as Mays Bridge Road, being a portion of the 5.47 acres shown on plat entitled "Irving L. Urch Property" as prepared by Lindsey & Associates dated July 5, 1979 and having according to said plat the following metes and bounds, to-wit:
