to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s), the receipt of which is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto John D. Hollingsworth on Wheels. Inc.. its successors and assigns forever:

All that certain piece and parcel of land situate, lying and being in the County of Greenville, State of South Carolina, Gantt Township, in Donaldson Center on the south side of Firehouse Street, bounded on the west by Perimeter Road and on the southeast by a taxiway right-of-way, and bounded on the southwest by property of Donaldson Center, and having, according to a plat prepared by J. L. Montgomery, III, Registered Land Surveyor #4552, on May 1, 1978, which is incorporated herein by reference, the following metes and bounds, to wit: said plat being recorded in R.M.C. Office for Greenville County in Plat Book 7-0 Page 9: Beginning at an iron pin on the south side of Firehouse Street adjacent to the taxiway right-of-way and running thence N. 55-28 W. 287.58 feet along Firehouse Street to an iron pin; thence running N. 53-19 W. 239.7 feet along Firehouse Street to an iron pin; thence running N. 76-27 W. 93.4 feet to an iron pin; thence running S. 88-10 W. 106.94 feet to an iron pin on the east side of Perimeter Road; thence running S. 3-06 W. 442.85 feet along Perimeter Road to an iron pin; thence running S. 57-44 E. 442.38 feet along the southwest side of a drainage ditch to an iron pin; thence running N. 37-53 E. 449.11 feet along the west side of the taxiway right-of-way to the point of beginning, containing 6.14 acres; being a portion of the property conveyed to grantors by deed recorded in the R.M.C. Office for Greenville County in Deed Volume 740, page 573, on January 25, 1964, conveyed by United States of America.

The City and County are responsible for payment of tax stamps, if any.
Also: A non-exclusive easement of ingress and egress in and to the presently existing aircraft runway located within the Donaldson Center Industrial Air Park. Said easement specifically includes, but is not limited to, the right to use the existing runway for take-offs and landings of aircraft, so long as said runway is open to anyone for use as a runway by any type of aircraft.
