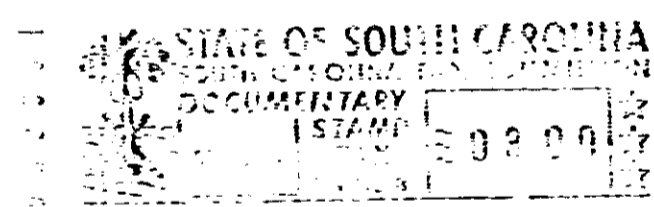
Reference to said plat is hereby craved for a more particular description.
