in consideration of Forty Thousand and No/100 (\$40,000.00) Dollars,

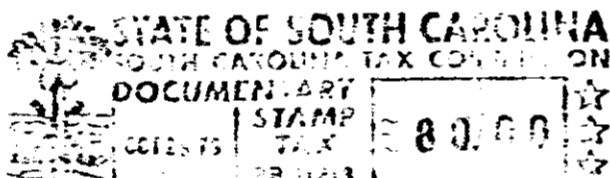

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, having the following metes and bounds according to a survey made by R.E. Dalton, Engineer:

COMMENCING at an iron pipe on the south side of Grove Road at the corner of Lot Number 7, thence along the south side of said Road, S 45-27 W 32.6 feet to a pipe at the corner of a 13 degree and 26 minute curve to the left; thence around said curve to an iron pipe at the corner of Lot 5, the course and distance of said chord being, S 43-37 W 27.4 feet; thence along the line Of Lot 5, S 51-06 179.8 feet to an iron pipe on rear line; thence along the rear line, N 45-27 E 50 feet to an iron pin, corner of Lot 7; thence along the line of Lot 7, N 47-52 W 180 feet to the point of beginning; said lot being known as Lot Number 6, Block N of the Property of O.P.
