more particular description thereof.

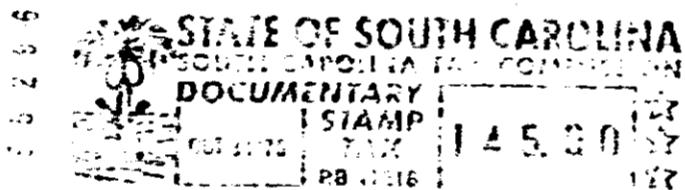

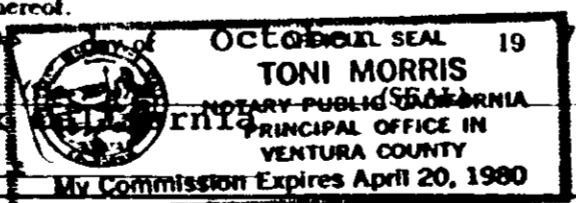
