release unto **BUILDERS & DEVELOPERS, INC.**, its successors & assigns forever:

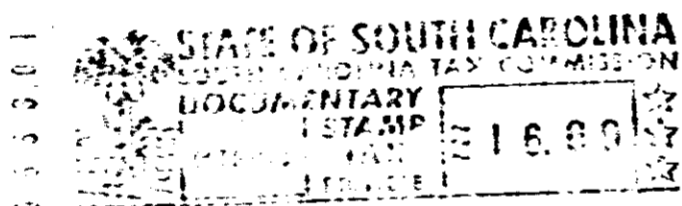
ALL that piece, parcel or lot of land, situate, lying and being in the State
