CONTRACT FOR DEED

The Buyer agrees to pay the said purchase price of said property in the manner and at the time above set forth, time being declared of the essence of this Contract, and in the event of sixty (60) days default by the Buyer in making any of the payments herein provided on, then, at the option of the Seller all rights and interest of the Buyer under this reement may thereupon be declared terminated by the Seller, and in such event all money aid by the Buyer under the provisions of this Agreement may be retained by the Seller as ental or liquidated damages of said property, and said Contract shall thereafter be cancelled, in the Seller may take and enjoy any other remedy which may be proper in the premises.
